### **3 Approval Object**

The approval objects are defined as

- Kopfstelle of the girocard-system
- Übergabestelle of the girocard-system
- Kopfstelle of the German ATM-system
- Übergabestelle of the German ATM-system

(see "GBIC Approval Scheme", chapter 5.9).

#### **3.1 Description**

The four individual approval objects allow the approval of operating host systems to provide the respective tasks either for one or both of the two schemes, the German ATM-system and the girocard-system.

Each "Kopfstelle" and "Übergabestelle" has to support specific functions to be in compliance with the required functional requirements. The required functions depends on the approval object as defined in the technical annex.

Each approval object consists of one evaluation object containing the security evaluation of the hardware and software of the Host Security Module and the evaluation of the operating environment of the host system including the security manager.

Each "Kopfstelle" and "Übergabestelle" already productive before the signing of the approval contract must fulfil these requirements for all changes of the existing evaluation object.

In the following tables the columns represent possible combinations whereas

- "M" means "function is mandatory",
- "C" means "function is conditional" and
- "-" means "function is not allowed".

## 4 Approval Object "Kopfstelle of the girocard-system"

### 4.1 Description

A "Kopfstelle" is entitled to exchange online messages with network providers or with a "Passiv-Übertragabestelle".

Therefore the "Kopfstelle" has to support two functions (in consideration of conditions):

- "Kopfstelle (Netzbetreiber)" (mandatory according to "Kopfstelle" defined in [KÜS TA2.0], chapter 2.1), which exchanges online messages with network providers approved for the girocard-system to forward the messages to the dedicated authorisation systems,
- "Passiv-Kopfstelle (Kooperation)" (conditional function according to "Passiv-Kopfstelle" defined in [KÜS TA2.0], chapter 4.2), which exchanges online messages with an approved "Übertragabestelle of the girocard-system" supporting the function "Passiv-Übertragabestelle (Kooperation)" to forward the messages to the dedicated authorisation systems.

#### 4.5 Interfaces to be tested

The "Kopfstelle" ensures the interoperability of the implementation of all requirements described in the technical appendix of the Approval contract. The appropriate interoperability testing must be confirmed in written form according the testing conformance statement (TCS) (see chapter 8)

- for the "Kopfstelle (Netzbetreiber)" with at least one network provider approved for the girocard-system,

#### **4.6 Migrations**

"Kopfstellen" already productive before the signing of the approval contract are declared as approved in general.

"Kopfstellen" already productive before the signing of the approval contract have to follow this requirement for all changes of the existing evaluation object.

The general approval of "Kopfstellen" without support of AES based PAC/MAC expires at 31.12.2024. The AES support is mandatory from 01.01.2025. This means, the AES approval must be completed until 31.12.2024.

## 5 Approval Object "Übergabestelle of the girocard-system"

### 5.1 Description

An "Übergabestelle" is entitled to exchange online messages with network providers or with a "Passiv-Kopfstelle (Kooperation)" in the girocard-system.

The "Übergabestelle" has to support at least one of the two functions:

- "Übergabestelle (Netzbetreiber)", which exchanges online messages with network providers approved for the girocard system to forward them to systems of cooperation partners (see chapter 3.1 in [KÜS TA2.0]),
- "Passiv-Übergabestelle (Kooperation)", which exchanges online messages with systems of cooperation partners to forward them to an approved "Kopfstelle of the girocard-system" supporting the function "Passiv-Kopfstelle (Kooperation)" (see chapter 4.1 in [KÜS TA2.0]).

The approval as "Übergabestelle of the girocard-system" is currently not yet possible. It depends on the acceptance of girocard cards by cooperation partners (see "GBIC Approval Scheme", chapter 5.9.3.1) and has to be decided in the future by GBIC.

A "Kopfstelle" is entitled to exchange online messages with an "Übergabestelle" or with other "Kopfstellen" in the German ATM-system.

The "Kopfstelle" has to support at least one of the two functions:

- "Aktiv-Kopfstelle", which exchanges online messages from ATM providers (see chapter 2.2 in [KÜS TA2.0]) and online messages from an "Übergabestelle of the German ATM-system" supporting the function "Aktiv-Übergabestelle" (see chapter 3.2 in [KÜS TA2.0]), both to forward them to an approved "Kopfstelle of the German ATM-system" supporting the function "Passiv-Kopfstelle",
- "Passiv-Kopfstelle", which exchanges online messages with an approved "Kopfstelle of the German ATM-system" supporting the function "Aktiv-Kopfstelle" (see chapter 2.2.1 in [KÜS TA2.0]) and with an approved "Übergabestelle of the German ATM-system" supporting the function "Passiv-Übergabestelle" (see chapter 4.2 in [KÜS TA2.0]), both to forward them to the authorization systems of the mandating issuing payment service provider, both for girocard cards.

## 7.5 Interfaces to be tested

The "Übergabestelle" ensures the interoperability of the implementation of all requirements described in the technical appendix of the Approval contract. The appropriate interoperability testing must be confirmed in written form according the testing conformance statement (TCS) (see chapter 8)

- for the "Aktiv-Übergabestelle" by all "Kopfstelle of the German ATM-system" approved supporting the function "Aktiv-Kopfstellen",
- for the "Passiv-Übergabestelle" by all "Kopfstelle of the German ATM-system" approved supporting the function "Passiv-Kopfstellen".

## 7.6 Migrations

"Übergabestellen" already productive before the signing of the approval contract are declared as approved in general.

"Übergabestellen" already productive before the signing of the approval contract have to follow this requirement for all changes of the existing evaluation object.

## 8 "Testing Conformance Statement (TCS)"

For each new processing partner the interoperability interfaces have to be documented and their appropriate testing has to be confirmed by the already approved processing partner. The following form must be used for documentation and confirmation (see "GBIC Approval Scheme", chapter 5.9).
